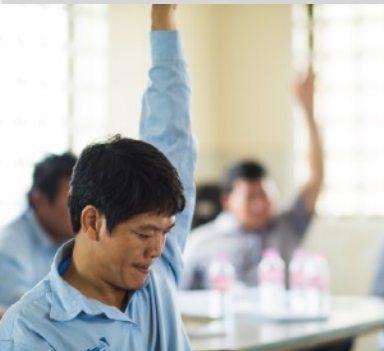

Collaboration in Practice

Collaboration is critical to address complex issues of human trafficking, exploitation and abuse.

While governments and nongovernmental organizations have made considerable progress in their efforts to address trafficking in recent years, there remain several gaps and challenges if trafficking and exploitation are to be brought to an end. The movement itself has not always been strategic and collaborative in its response, and there remain several gaps and challenges if trafficking and exploitation are to be brought to an end.

Coordination among government agencies, NGOs and grassroots movements is currently insufficient at the national, regional and international level.

Individual organizations are often overwhelmed by the reality of issues at the ground level. Many lack understanding of the broader national, regional and global perspectives on trafficking, fail to collaborate toward effectively addressing the issue, and do not have sufficient access to sustainable networking opportunities or updated research and training.

Chab Dai prioritizes building, strengthening and connecting this movement.

CAMBODIA PROJECTS

Collaboration

Coalition

Our coalition in Cambodia works toward collective impact against trafficking and abuse by raising standards of care, promoting best practices, and providing members with opportunities for collaboration, mentoring, and training.

- ✓ Provided training for member staff on mental health, organizational development, child participation, human trafficking and human rights with **328 participants** (**150%** of our initial prediction)
- ✓ Facilitated **focus forums** for caregivers, expats, on human resources, and financial management with **183 participants** (up 12% from 2015)
- ✓ Updated Chab Dai Charter indicators, assisting Charter members further improve their programs
- ✓ Hosted **621 member staff** at our bi-annual member meetings in Phnom Penh, and **47 member staff** at member meetings in the provinces
- ✓ Expanded our member resource library by **320 resources**: 207 in English, 111 in Khmer, and 2 in Vietnamese
- ✓ Distributed **93 newsletters** with information regarding opportunities for training, coalition activities and other upcoming events to over **153 subscribers**

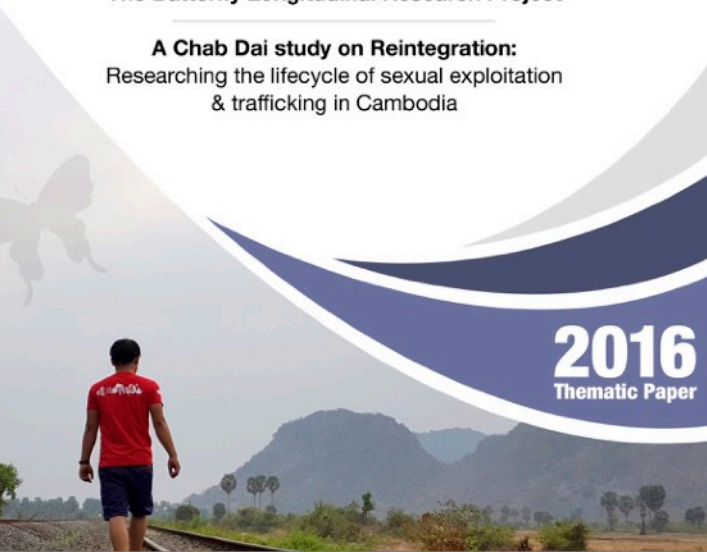
Research

Butterfly Reintegration Study

Butterfly is a 10-year longitudinal study examining the (re-)integration of sex trafficking survivors in Cambodia. The objective is to understand (re-)integration from the perspective of survivors themselves.

- ✓ Completed our **7th year** of research
- ✓ Produced our first paper focused solely on **male survivor** experiences of recovery
- ✓ Conducted **177 interviews** with **94 participants** of the study
- ✓ Presented findings to **four audiences in Cambodia**, and last year's paper on filial piety at a **conference in Japan**
- ✓ Distributed **935 copies** of last year's thematic papers on filial piety and stigma

CAMBODIA *Prevention*



Safe Communities

Trains community leaders across Cambodia, empowering them to protect their community from trafficking, abuse and exploitation

- ✓ Trained **53 influential leaders** and raised awareness among **990 community members** about trafficking, abuse, and how to protect themselves and others
- ✓ Organized **6 live radio shows, broadcasted 150 times** and facilitated **24 Q&A radio programs** on trafficking, sexual abuse, safe migration and forced marriage.
- ✓ Launched **mobile broadcasting** in 6 rural communities, reaching 3,674 people

Ethnic Community Prevention

Empowers ethnic minority communities in Cambodia to protect those at risk of sexual abuse and trafficking

- ✓ Conducted bilingual training on trafficking, sexual abuse and safe migration with **768 community members**
- ✓ 45 families participated in workshops on **parenting skills**, and 26 families completed training on **entrepreneurship**, with 24 of these families now running their own small businesses
- ✓ Maintained positive relationships with **10 community leaders** in communities where we work, who **reported 30 cases to our team**



Community Heroes

Preventing trafficking in rural areas of Cambodia by empowering and encouraging volunteer trainers (heroes) to protect their communities

- ✓ Provided ongoing support for **68 community heroes**, including providing them with 40,000 leaflets, 60,000 help cards, 68 poster flip charts, new bags and t-shirts, new books on trafficking and migration
- ✓ **79%** of our heroes **responded to cases** in the communities where they provide training
- ✓ Heroes reached **10,772 people in 230 villages in 4 districts of Prey Veng province** with education on safe migration, trafficking, and child rights

*Advocacy *NEW!*

Work with policymakers, local police and members of the community to strengthen understanding and implementation of child rights in Cambodia

- ✓ Completed **needs assessments** with 33 police officers, and **trained 31 police on child rights**
- ✓ **Provided commune police** with 490 posters on child rights, safe migration, and needs of victims; 160 books on child rights, 4,000 help cards, 2,500 stickers and information on case support services
- ✓ Contributed to relevant **bilateral government meetings** between Cambodia and China, and COMMIT in Laos

CAMBODIA *Justice*

Case Support

Provides hotline, legal and referral support for local and international victims of trafficking, and abuse.

- ✓ Provided local legal support for **160 trafficking** and **37 rape cases**, with **100% prosecution on rape cases**
- ✓ Case support for **75 new cases in China** (53 for forced marriage), with 18 brokers arrested as a result; **82 new cases in Malaysia** and 14 brokers arrested; and **2 cases in Thailand**
- ✓ Received **150 calls** to our case hotline
- ✓ Supported **50 flights for repatriation** of victims

Community Client Care

Support for Cambodian social workers and counselors working with survivors in the community.

- ✓ Provided social services for **24 new cases, 4 counseling sessions per case**
- ✓ Organized **social work conference**, with **191 participants**; 85% said what they learned was directly relevant to their work
- ✓ Provided **transportation, food and additional supplies** to families, in addition to **77 total counseling sessions**

Asia

GLC Asia partners and exchanges lessons learned with counter-trafficking stakeholders primarily in **Asia**

- ✓ Assisted **158 partners in 29 countries**
- ✓ Partnered with Liberty Asia for expansion of **Freedom Collaborative**, an online platform strengthening cooperation among international counter-trafficking stakeholders, ending the year with users from **367 organizations in 42 countries**
- ✓ Participated and contributed to **workshops at major conferences** in Singapore, Hong Kong, Philippines, Japan, Sweden, Canada, USA & UK

Americas

GLC Americas shares information, expertise and resources with partners throughout **Latin America**

- ✓ Worked with NGO and government partners in **6 countries - Costa Rica, Dominican Republic, Guatemala, Mexico, Honduras, and Colombia**
- ✓ **Translated and helped contextualize** aftercare training materials from **FAAST International** into Spanish for Latin America partners
- ✓ Assisted partners map programs in their country with plans to help establish a **regional coalition**
- ✓ Facilitated an exchange trip **for Latin America partners** to visit **Chab Dai projects in Cambodia**

Chab Dai Cambodia is registered with the Royal Government of Cambodia's Ministry of Foreign Affairs under the sponsorship of Chab Dai International.

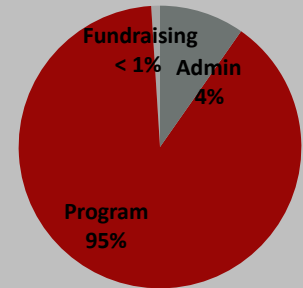

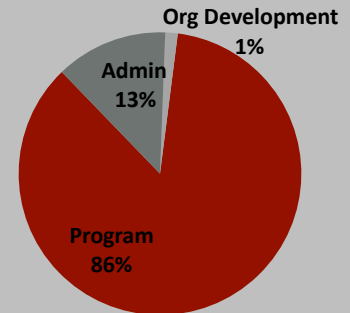

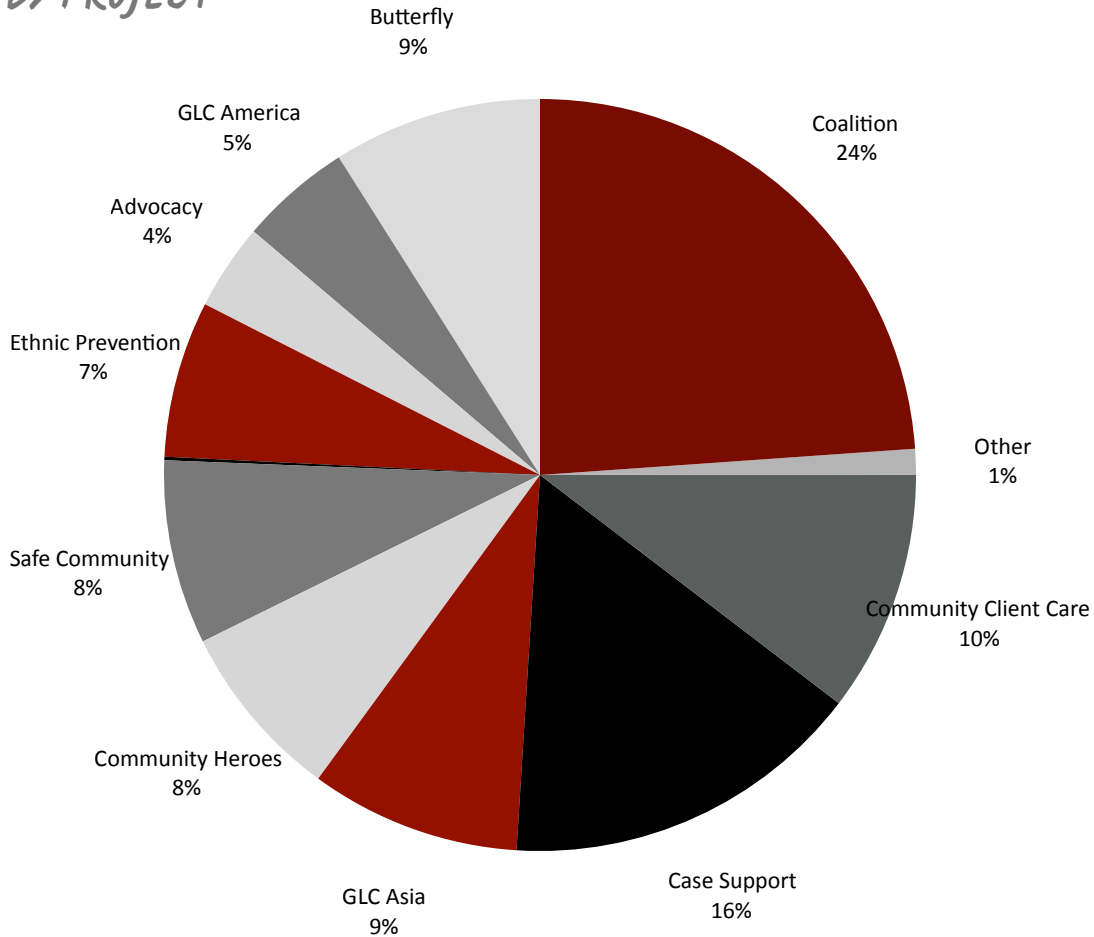
